## **Co-President's Report:**

- Introduction of Board to prospective board members attending
- Actively recruiting open board positions
  - $\circ$  Two have expressed an interest in the Treasurer positon for the board and store
  - Looking for a store manager
    - Could split into a shared role
- Discuss P.O. box protocol
  - Mary continue to pick up to collect checks and let Amy know if any new memberships or tell Angie if there are any Senior party registrations

## Secretary's Report:

• Lori motioned the approval of the February meeting minutes. Laura seconded the motion. Board voted and motion carries. Minutes were approved

## **Treasurer's Report:**

- Financial reports and profit and loss budget were distributed
- \$35,000 currently available
  - Down about \$25,000 from last year

## **Communication's Report:**

- Posted Be the change and Backpack tutoring on Instagram to spotlight clubs
  - Will post a spotlight every other week
- Will post the following on social media
  - Chipotle night in two weeks
  - Evereve on April 9<sup>th</sup>- will do a flyer and social media
  - o Booster Club Member list
- Follow the Booster Club/Store on social media
  - Notify board members via Group Me when a post is made
  - Like and share posts
- Tag the club/team that the post represents
  - Ask club/team representative to post about the Booster Club after they present for the \$100 Club
  - Ask the club/team what their account names are to tag them in posts

## **Committee Reports:**

#### Membership/Website:

- No new members
- Amy is able to print RevTrak reports
  - Connect with Amy for report requests
- Amy will send member list to Cym

#### **Booster Store:**

- Back to school budget reduced to between \$46,000-\$48,000.
  - o Ordering basic "big cotton" apparel for early shipment
    - Less expensive if we order and deliver earlier than we previously had in the past
    - Bill will be due August 10<sup>th</sup>, 2020 and will be about \$6,000
    - Stacy and Traci will discuss holding back money to pay the August bill
- Six spring items that weren't processed have been cancelled
- Last vender meeting is next week
- Inventory is currently at \$53,00
  - Last year inventory at this time was \$51,000
- Historically the May discount promotion has been 20%
  - Increasing to 25% this year
- April 27<sup>th</sup> (week before May promotion) will be the start of a 25% "members only" sale for current Booster Club members
  - o Amy will provide the store with a current members list
  - Possibly mail an invite to current members to shop that week
- Beth and Lori met with the Tonka Pride representatives to discuss vender agreements
  - Lori confirmed with Ted that the Booster Club/Store has never signed an agreement with any of our venders
  - $\circ$   $\;$  If the district would like us to provide a venders list, we will
- Ipads and equipment all working smoothly

#### **Volunteer Coordinator:**

- Team Lead survey has had good responses and things are going well
- Survey will go out this week to team leads to forward to store volunteers
- Encourage all board members to volunteer in the store to be familiar with the process

#### **Fundraising:**

- Chipotle event scheduled for March 23<sup>rd</sup>
  - Will post flyers around the school
  - Pre-orders are not considered part of the promotion
  - $\circ$  33% of proceeds donated/given to the booster club
  - Cym will email Jacquie Gleeman verbiage to be included in Principal Erickson's Sunday email
    - Thursday at noon is deadline
- Evereve in Wayzata event scheduled for April 9<sup>th</sup> 6-9 pm
  - Asking Booster Club to promote and attend
- Bagging groceries at Cub on April 11<sup>th</sup> 10am 6 pm
  - o **101 & 7 location**
  - An adult needs to be there to supervise each shift
  - Starting to recruit volunteers now
    - Stacy will email Gwynn and Jane in the activities office a letter with the sign up genius link to send to all clubs and teams
    - Ask Michelle Seets to post in the Facebook group this as a volunteer opportunity
    - Clubs and sports that volunteer will be prioritized in the grant process
    - Provide the volunteers with a script of why they are bagging groceries and what the money will go towards
- Looking into an event at Top Golf
  - Sunday is the less expensive day of the week to hold an event
  - Initially looked at May 17<sup>th</sup>
    - May 16<sup>th</sup> is prom so attendance could be low
    - Dana to follow up with a new date
    - Will send out an update on Group Me for a board vote
  - Food and golf is provided with ticket fee and cash bar provided
  - Breaking even would be if we charged \$65 so looking into charging \$100/participant
    - Will look into food only- no golf fee
  - Hold a 50/50 raffle

## Senior Party:

- Registration is live for online only
  - Will accept cash/check one day before graduation
  - Cash/check only on the day of graduation
  - o 150 currently registered
  - Price is set at \$80 until March 15<sup>th</sup> and will go up to \$100 and on May 15<sup>th</sup> go up to \$150
- Angie had a table at conferences promoting the Spring Flower sale and handed out the senior party flyer to senior parents
- Through the end of February the net income for the party is at \$23,000
- Visited the venue and mapped out where the entertainment will be
  - Cut back on a few entertainment pieces due to space
  - Entertainment includes: photo booths, hypnotist, air brush tattoos, giant jenga, karaoke, 16 person foosball, etc...
- Chicken tenders and unlimited pizza were initially included with the event space
  - Angie was told they are now unable to accommodate the food
  - Angie is looking into working with Hy Vee
- Plant sale is active now through April 13<sup>th</sup>
  - No donations for printing services has been received for this year so no postcards going out to promote the sale
- Men's Wearhouse fundraiser is live for tux rentals
- Parent spring fundraiser is set for May 15<sup>th</sup>
  - Sail-abration is party theme
  - o Email invite was sent to all senior parents on Monday
  - Entry fee is a prize valued at \$25 or more
  - Famous Daves is catering the event
  - Event is being held at a senior parent home
