- Copy of current certificate from the Dept. of Health or state license (required for food sales/service/samples).

The 19th Annual Tour de Tonka bicycle ride will be held Saturday, August 3. The 65 & 100-mile rides will start at 7:00 a.m., at Clear Springs Elementary. The 16, 30, 36, and 47-mile rides will start at 7:30 a.m., at Minnetonka High School. All rides end at Minnetonka High School.

RIDER OVERVIEW

Whether it's as a business partner or a rider, there are a number of ways to get involved with Tour de Tonka this year. Below is an overview of who our riders are and how you can become a part of the Tour de Tonka team!

- Tour de Tonka celebrates over **2,500** riders per year. Since 2006, our riders have represented **73** of the **87** Minnesota Counties, and **44** States. *Minnesota's Ride!*
- Riders ranged in age from **1** to **89**, with **60%** of riders being between the ages of **40-69**.
- Generally, **70%** of riders are male, **30%** are female.
- **53** Legacy Riders remain. In year two we started tracking, rewarding and acknowledging the Tour de Tonka riders who have ridden each year since 2006.
- **80%** of riders said they participate in Tour de Tonka because they are interested in exercise and physical fitness.

Rest Stop Host

Rest Stop hosts are businesses and organizations who provide the enthusiastic and helpful volunteers to staff the rest stops. We provide t-shirts for all the volunteers, as well as the food and supplies needed to host a first-rate rest stop — including bike mechanics and live music! As a host, you and your team will prepare food and beverages, cheer on the riders, and direct them into the rest stop and back onto the route as they leave.

As a rest stop host, you may advertise your company with banners or posters at the rest stop. In addition, you will be included on the sponsors banners at the start and finish line, listed on our website, given social media shout outs and included in the information given to each rider in their virtual packet.

Vendor Fair Options

Option A (\$25): Friday & Saturday August 2 & 3, for sales to the public.

Friday, August 2: During rider packet pickup in the MHS West Gym:

- Set up: 8:30-9:30 a.m.
- Staff your booth from 9:30 a.m.–4 p.m.
- You need to supply your own tables & chairs.

Saturday August 3: Outside MHS in the Vendor Fair Area

- Move your items out of the MHS West Gym by 4 p.m. on Friday, August 2.
- Set-up your booth on Saturday at 9 a.m.
- Staff your booth from 9 a.m.–4 p.m. (you need to supply your own tables, chairs and tent).
- No gym set up will be allowed on Saturday.

Option B (\$25): Friday, indoors only

Friday, August 2: MHS Indoors in the Vendor Fair area.

- Booth set-up Friday, August 2 from 8:30-9:30 a.m.
- You will need to supply your own tables & chairs.
- Take down and remove booth and items by 4 p.m. on Friday.

Option C (\$25): Saturday, outdoors only

Saturday, August 3: MHS Outdoors in the Vendor Fair area. Note: No gym use on Saturday

- Set-up your booth on Saturday at 9 a.m.
- You will need to supply your own tables, chairs and tent.
- Take down and remove booth and items on Saturday at 4 p.m.

Option D (\$75): Virtual Rider Packet Flyer

All riders will receive the Virtual Rider Packet in their inbox prior to the event.

- Please let us know what you will be providing (digital flyers or coupons) in advance.
- Submit items to Minnetonka Community Education by Friday, July 19, 2024.

Fee, Insurance, Health Dept. License:

By signing this contract, the Vendor agrees to pay a non-refundable fee to Minnetonka Community Education. Vendor also agrees to provide a copy of Vendor's third party and public liability insurance policy. The minimum face value shall be \$100,000 per individual claim and \$300,000 per event. Food Vendor shall provide a current copy of the Minnesota Certificate of Health authorization to sell food items. Vendor also agrees to comply with the rules of the Minnetonka Police Dept. and the Hennepin County Health Dept. (food services).

Waste Removal:

Vendor agrees to remove all waste, boxes, food by-products, excess food, cooking grease, other by-products of food service operations from the site, and to pick up the litter in Vendor's immediate areas (surrounding booth) throughout the day and at the end of the event, to the satisfaction of TDT representative(s). We also require all cardboard boxes/egg cartons to be flattened BEFORE being placed in recycling receptacles.

Parking at Minnetonka High School:

Ride customers will park everywhere beginning at 5:30 a.m. on Saturday, August 3. Therefore, the parking lot will be extremely busy. Please plan accordingly.

Help us conserve parking spaces by carpooling and by not bringing a vehicle with a trailer to the high school during the day on Saturday.

Booth Space and Contract:

TDT will assign booth spaces.
